Instructions for Authors

What follows is a concise guide to the best way to prepare your text in a style and format that is suitable for production at Springer Nature.

Preparation

- Manuscripts shall be submitted via email to info.errn2020@ateneo.univr.it
- Please write your manuscript in a **word-processing package**, such as Word and make sure that the entire script (including notes) is double-spaced.
- Chapters should be between 5,000 to 8,000 words in **length**.
- Chapter **abstracts** are strongly encouraged. The abstract shall summarize the content of the chapter in no more than 200 words.
- Three to six **keywords** are required. Each keyword should not contain more than two compound words, and each keyword phrase should start with an uppercase letter.
- **Heading levels** should be clearly identified and each level should be uniquely and consistently numbered by using the decimal system of numbering.
- **Technical terms** and **abbreviations** should be defined the first time they appear in the text.
- **Numerals** should follow the British method of decimal points to indicate decimals; commas should be used to separate thousands.
- **Italics** should be used for emphasized words or phrases in running text, but do not format entire paragraphs in italics.
- In Word, use the Math function, MathType, or Microsoft Equation Editor to create your **equations**, and insert the graphic into your text file as an object.
- Use **British spelling** except for quoted material. Centuries should be written out in full (e.g., eighteenth century). Decades should be written as numerals (e.g., the 1970s).
- Give each **table** a caption. Add a reference citation to the table source at the end of the caption, if necessary. Number tables consecutively and ensure that all tables are cited in the text in sequential order. Do not write “the following table”. Please use the table function to create and format tables (do not use the space bar or multiple tabs to separate columns and do not use Excel to create tables).
- Give each **figure** a concise caption, describing accurately what the figure depicts. Include the captions at the end of the text file, not in the figure file. Number the figures chapter-wise and ensure that all figures are cited in the text in sequential order. Do not write “the following figure”.

Referencing

- All the references given in the list of references should be cited in the body of a text.
- **Citation** is reported by name of cited author and year of publication:
 - One author: (Miller 1991) or Miller (1991).
 - Two authors: (Miller and Smith 1994) or Miller and Smith (1994).
 - Three authors or more: (Miller et al. 1995) or Miller et al. (1995).
- We would prefer the use of **Harvard** referencing throughout if possible.
- In the **Reference list**, entries must be in alphabetical order except in the numbered system of sequential citation. The rules for alphabetization are:
 - First, all works by the author alone, ordered chronologically by year of publication.
 - Next, all works by the author with a coauthor, ordered alphabetically by coauthor.
 - Finally, all works by the author with several coauthors, ordered chronologically by year of publication.
